- B. Student **Iris Lee** (1) spoke about Parkland students and student walkout planned for March 14th

Student **Niki Woods** (1) spoke about Parkland students and student walkout planned for March 14th

Student Jack Zirin-Hyman (1) spoke about student planned walk out

Mr. Schliem of 207 Hardenburgh Ave. (1) spoke about the March 14th walkout as a political event (2) commented that the school administration are allowing students to participate in a political event (3) asked when the board of education was made aware of this event and noted that he feels the information was vague and misleading (4) asked what plan was in place for students who did not wish to participate

Mr. Woods of 12 Demarest Ave. (1) spoke in support of the student walk out **Mrs. Marks** of 14 Van Horn (1) noted the walk out is not about politics but about the students

Mrs. Collins of 42 Everett Rd. (1) disagrees that this is a political action and notes that the point of the walk out is feeling safe at school (2) asked if the event will take place inside

Mrs. Miller of 40 William St. (1) asks why it is so difficult for the walk out to take place NVRHS students Samantha Marks (Demarest) and Ishita Jamar (Closter) (1) spoke about the NVRHS walk out on March14th in memorial to the 17 Parkland school victims Student Sachin Kirtane (1) said student council members will walk in unity with the other students; DMS is a community of kindness and empathy

Ms. Tutunjan of 8 John St. (1) voiced that this is political which is not bad; good process for students (2) praised the students and board of education

Mrs. Steiner of 33 William St. (1) noted it is great opportunity to bond as one (2) allows students voices to be heard

Ms. Nankani of 23 Old Stable Rd. (1) feels Demarest is a safe town with community events and is creating responsible citizens by allowing the walk out

Mrs. Zirin-Hyman of 7 Poplar Rd. (1) said the event is about student safety and voices to be heard; not a political event

Mr. Kirtane of 4 Bogert Rd. (1) this is a student event, not a parent led event; them not us

Mrs. Alevrontas of 69 Van Horn St. (1) teaching the students how to show kindness (2) asked about the logistics of how the walk out is taking place

Mr. Fernandez of 9 Grove St. (1) what if a student wants to go outside
