of those present to approve the following resolution, as recommended by the Chief School
Administrator:

Be it Resolved, that the Board of Education of Demarest, upon the recommendation of the Chief School Administrator, approves the following preliminary 2019/2020 school year budget using the 2019/2020 state aid amounts and authorizes the Business Administrator/Board Secretary to submit the preliminary 2019/2020 school year budget to the Executive County Superintendent for approval in accordance with statutory submission dates:

General Fund	\$17,177,314
Special Revenue Fund	137,108
Debt Service Fund	616,700
Total Appropriations	\$17,931,122

Be it Further Resolved, that the General Fund tax levy of \$14,486,825 is approved to support General Fund Expenses and \$616,700 is approved to support the Debt Service Fund for the 2019/2020 school year.

It was moved by Kirtane, seconded by Governale and approved by unanimous roll call vote of those present to approve the following resolution, as recommended by the Chief School Administrator:

WHEREAS, the Demarest Board of Education recognizes school staff and Board members will incur travel that promotes the delivery of instruction or furthers the efficient operation of the school district; and

WHEREAS, in accordance with school district Policy No. 6471 the Board of Education establishes per N.J.A.C.6A:23A-7.3, for regular district business travel only, an annual school year threshold of \$1,500.00 per staff member for the 2019/2020 school year and where prior Board approval shall not be required unless this annual threshold for a staff member is exceeded in a given school year (July 1 through June 30); and

WHEREAS, the Board of Education established a maximum amount of \$35,000 for the 2018/2019 school year and incurred travel and related expenses as of February 28, 2019 in the amount of \$12,515 for the 2018/2019 school year; now

THEREFORE, BE IT RESOLVED, the Board of Education approves travel and related expense reimbursements, in accordance with school district Policy No. 6471 and N.J.A.C.

6A:23A-7.3, to a maximum expenditure of \$35,000 for all staff and board members for the 2019/2020 school year, as recommended by the Chief School Administrator.
